**To the person in 2 :**

At the hearing, the judge can renew the current restraining order for another five years or permanently. Before the hearing, you can file a response on Form DV-720(TC). You *must* continue to obey the current restraining orders until the expiration date on the current orders or the hearing date, whichever is later. At the hearing, you can tell the judge why you agree or disagree with the request to renew the orders. If the restraining orders are renewed, you *must* obey the orders even if you do not attend the hearing.

## 4 Service and Response

### To the Person in 1

Someone 18 or over—**not you or anyone else protected by the restraining order**—must personally “serve” a copy of the following forms on the person in **2** at least \_\_\_\_\_ days before the hearing.

- DV-700(TC), *Request to Renew Restraining Order* (file stamped);
- DV-710(TC), *Notice of Hearing to Renew Restraining Order* (this form);
- DV-720(TC), *Response to Request to Renew Restraining Order* (blank copy);
- DV-130(TC), the current *Restraining Order After Hearing (Order of Protection)* that you want to renew.

After the person in **2** has been served, file Form DV-200(TC), *Proof of Personal Service*, with the court clerk. For help with service, read Form DV-200(TC)-INFO, *What Is “Proof of Personal Service”?* **Bring a copy of Form DV-200(TC), *Proof of Personal Service*, to the court hearing.**

### To the Person in 2

If you want to respond in writing to the request to renew the restraining order, fill out Form DV-720(TC), *Response to Request to Renew Restraining Order*. File the original with the court, and have someone 18 or over—**not you**—mail a copy of it to the person in **1** before the hearing. Also file Form DV-250(TC), *Proof of Service by Mail*, with the court before the hearing. **Bring a copy of Form DV-250(TC), *Proof of Service by Mail*, to the court hearing.**
