**ORDER FOR DISPOSAL &
DESTRUCTION OF EVIDENCE**

The Court having received a request and memorandum from duly sworn Evidence Specialist Erin Nomura and Yurok Tribal Police Chief Greg O'Rourke requesting disposition of evidence identified in the attached inventory held by Yurok Tribal Police which has become unidentifiable due to age and/or has become a health hazard due to mold, makes the following orders:

The Court hereby grants the request to destroy said evidence, as it pertains solely to those items on the attached inventory deemed as unidentifiable or untraceable but no longer usable because of being "moldy" and/or "rotten". Said items thereby constituting a health hazard the Court hereby orders the immediate safe destruction of evidence so categorized on said inventory.

The Court further orders any item on the list that is not deemed to constitute a health hazard be donated to the Yurok Public, with priority for said items to be given to elders of the Yurok Tribe. Yurok Tribal Police are instructed to contact Yurok Health & Human Services, Yurok Indian Housing Authority, and other departments of the Yurok Tribe or associated businesses to complete the donation of said items as the Department (Chief) deems appropriate.

If after a time period of 60 days and following a good faith attempt to donate items that are eligible for donation, there are remaining items the Court orders the Department may destroy or dispose of any remaining evidence items on the attached inventory at the discretion of the Department (Chief).
